Announcements and discussion included the Annual Club Gift of \$5.00 per member to the Kiwanis International Foundation, the upcoming Key Leader events, the Mid-Year Conference and CLE training.

The only action item was a report and recommendation from the ad hoc committee appointed at the last Division Council meeting, with Jan Larson as chair, to address the funding of our Division. The committee recommended that each club be asked to donate \$2.00 per member to help offset the operating expenses for Division 5. The recommendation was accepted and approved unanimously, effective immediately.

Gov. David, presiding over the remainder of the meeting, asked each club to share their best service project and fund raiser, and their newest service project and fund raiser. Judging from the comments and discussion, Division 5 clubs are alive and active.

Governor's Official Visit

Eighty-five people attended Gov. David and First Lady Betty Olinger's official visit to Division 5. Following a delicious meal served by Damon's, five students for Wears Valley Ranch, a Christian home for children, entertained the group with singing accompanied by guitar music. Before leaving the stage, each student gave a personal testimony which was uplifting and appreciated by attendees.

Gov. David outlined the K-T District goals and encouraged our Division to aim high and work toward those goals. 1) At least 13% net membership gain, 2) Increase service hours by 10%, 3) Increase number of Service Leadership Organizations, 4) Increase convention attendance and 5) Emphasize Kiwanis education such as CLE.

Membership Growth

Has your club had a net membership 5% this year? Judging from the current membership report from Kiwanis International, we have a lot of work to do. Our Division is currently looking at a **net loss of 29 members**. Only three clubs have a net membership gain. Remember; TEAM ASK "Together Everyone Accomplishes More." All we have to do is "Actively Seek Kiwanians." We can achieve a 12 percent net membership gain if we all ask people to visit our clubs and become involved.

February and March Considerations:

- Make your Annual Club Gift of \$5.00 per member to the Kiwanis International Foundation?
- Determine to achieve a net membership gain of at least 6 percent by the end of March, the first half.
- Personally contact members who have not been attending your meetings.
- Send your contribution of \$2.00 per member to Division 5. Make your check payable to Kiwanis Div. 5 and send to Ralph Harness, 4504 Crestfield Rd, Knoxville, TN 37921.
- Review progress toward being a Distinguished Club this year.
- Follow up on 1st Lady Betty's Diversity in Reading project.
- Elect two delegates and two alternates to represent your club at the International Convention.
- Pay club dues to Kiwanis International by March 31 if your club's anniversary date is January, February, March or April.
- Set your Annual Club meeting date and appoint your nominating committee.
